Under Georgia law, it is a misdemeanor to make false or fraudulent claim for exemption. Persons guilty of fraudulent claims will be subject to taxation in an amount double the tax otherwise due.

I, the undersigned, hereby request registration of my vehicle(s) at the above address, and do solemnly swear that the statements made in support of this application are true and correct; that I am the bona fide owner of the property described in this application; that I actually occupied/will occupy this property on January 1st of the year for which this application is made; that I am an eligible applicant for the exemption applied for, qualifying or meeting the definitions of the word "applicant" as defined by O.C.G.A. 48-5-40; that I request any existing homestead exemptions be removed from other properties; and that no transaction has been made in collusion with another for the purpose of obtaining a homestead exemption contrary to the law. Furthermore, I also understand that at anytime I become ineligible for this Homestead Exemption, it is my duty to notify the Tax Commissioner of the change in my residency status.

Legal Definition of the word "applicant" is (a) A married individual living with their spouse; (b) An individual who is unmarried but who permanently maintains a home for the benefit of one or more other individuals who are related to such individual or dependent wholly or partially upon such individual for support; (c) An individual who is widowed having one or more children and maintaining a home occupied by himself or herself and the child or children; (d) A divorced individual living in a bona fide state of separation and having legal custody of one or more children, when the divorced individual owns and maintains a home for the child or children; or (e) An individual who is unmarried or is widowed who permanently maintains a home owned and occupied by himself or herself.

Additional information: State law requires that <u>all owned or leased vehicles must be registered in the county where the owner claims homestead exemption.</u> People registering vehicles or claiming homestead exemption in another state or county are not entitled to homestead exemption in DeKalb County. State law provides for only one homestead exemption per immediate family group (husband and wife). Homestead exemption cannot be claimed on rental property.

Remember, the filing period is January 2^{nd} through April 1^{st} for the current year. Applications received after April 1^{st} will be processed for the following year.

In addition to the basic homestead exemption available to all homeowners, there are special exemptions available for citizens 62 and older, disabled veterans or their un-remarried spouses, the un-remarried spouse of service member killed in action, and other disabled residents. Senior citizens over 65 are eligible for an exemption from state ad valorem taxes. The widowed, un-remarried spouse of a peace officer or firefighter killed in the line of duty may be exempt from all ad valorem property taxes. Eligibility is based upon age, disability, and household income and must be applied for <u>in person</u> at one of the Tax Commissioner's office locations printed on the reverse side.
