Each year, the staff and I work jointly to achieve customer-oriented results, operate efficiently, maintain our trustworthy reputation, and be good stewards of the resources under our care. In this report we highlight some accomplishments in the following areas: customer service, community, financials, and innovation/technology. This past year, we continued to achieve high marks on customer service. We successfully passed State, County, and City accounting and financial audits. We invested in staff training and development, technology enhancements, and cash management control. Through the continuing efforts of our excellent staff, our reputation still ranks among the best in Georgia and DeKalb County.

In 2019, we continued to work on our vision regarding the values we deem important to achieving our stated mission. We are committed to providing excellent customer service and transparency; meeting ethical standards; practicing personal integrity; and valuing a positive work ethic, honesty, and teamwork. Community service and education are becoming hallmarks of our Property Tax Division. We completed more than 30 on-site visits at neighborhood association meetings and events around the County. We have placed a special focus on educating seniors and veterans as well as current and potential homeowners about tax-saving homestead and motor vehicle exemptions. We have identified qualified tax payers and provided thousands of dollars in tax savings. We achieved this by presenting tax bill seminars at senior centers, homeowner associations, and other organizations throughout the County.

Over the past 4 years, our 7 self-service, motor vehicle registration kiosks have handled more than 142,000 transactions. Taxpayers now have more convenience and efficiency, as well as expanded service hours without adding labor costs. We now have 7 kiosks in DeKalb compared with 2 in 2016. Customer Service

- Offered a notary service to motor vehicle customers to expedite tag and title processing
- Installed infomercial screens in motor vehicle lobbies to inform taxpayers of legal requirements while they await service
- Initiated paperless, web-based billing service for motor vehicle and property tax customers
- Installed "wait time" TV monitors in motor vehicle lobbies and on the website; customers can view average wait times and then choose a location to visit

Community

- Conducted tax awareness sessions at more than 30 community events
- Participated in multiple DeKalb County forums and Town Hall events aimed at informing taxpayers about our services and tax saving options
- Increased number of self-service, tag renewal kiosks from 2 in 2016 to 7 in 2019
- Increased the number of senior homestead exemptions by 18% since 2015 through outreach efforts at DeKalb County senior centers

Financials

- Continued to achieve Tax Digest approval in 2019, which keeps tax billing, County budgeting, and operational planning on track
- Achieved collections of 96.77% of current year property taxes
- Received and disbursed approximately \$1.3 billion to County, school, cities, Tax Allocation Districts (TADs), and Community Improvement Districts (CIDs)
- Installed cash management equipment to improve workflow, collection accuracy, and reduce over-time requirements
- Returned nearly \$380K to the general fund balance and nearly \$1 million over the past 4 years
- Managed a 67% increase in tax districts and levying authorities while maintaining our high level of customer service (Tax districts have increased from 39 in 2014 to 65 in 2019)


Innovation/Technology

- Implemented the new State-wide system for tags/titles called DRIVES (Driver Registration Integration Vehicle Enterprise System) in May 2019
- Our staff trained motor vehicle staff, locally and around the State, on the DRIVES system
- Received a Horizon Interactive Award for excellence in media production; our redesigned website makes it more user friendly for taxpayers
- Installed "First-In-Line" call-back software in our Call Center. Now, customers can opt to have a callback versus waiting "on hold"
- Installed self-service, check-in kiosks in our lobby for customer use at our Central Office
- Renovated the Motor Vehicle lobby at our Central Office on Memorial Drive to improve security and customer flow
- Preserved historic tax documents and records by converting 6.6 million microfiche files to a digital format





Property Tax Digest





The DeKalb County Tax Digest is presented annually to the Georgia Department of Revenue for approval prior to the creation of tax bills. The Property Tax Digest is the sum of all of the assessed values, after exemptions, of properties to be taxed within the County.

The Board of Tax Assessors is the agency charged with the responsibility of establishing the fair market value of property for ad valorem taxation purposes. This Board determines property values based on recent sales and market conditions.


Notices of current value assessment are mailed to all property owners each spring. If a property owner has a disagreement with a property appraisal, an appeal may be filed up to 45 days from the notice date on the assessment form.

The governing body of each taxing authority annually establishes the millage rate, which is the determining factor in the calculation of taxes.

It is the responsibility of the Tax Commissioner to calculate tax bills based on the values set by the Assessor's Office and the millage rate established by the governing body.



Delinquent Property Tax





Delinquent properties that have not been paid as of December 31st will have a lien placed on the property. Once the lien is placed on the property, fees, and penalties will be added to the tax amount due. If payment is not received, the property is subject to being sold at a tax sale. These tax sales are held on the first Tuesday of each month, usually between April and December. Notice of tax sales are advertised in *The Champion Newspaper* once a week for four weeks prior to the sale.










Homestead Exemptions

To be granted a homestead exemption, taxpayers must actually occupy the home, and the home is considered the legal residence for all purposes.



Senior Exemptions



Types of Homestead Exemptions

H1 – Basic: No income limit

H3 – Senior or Disability: Georgia net income limit \$10,000

H4 – Senior Exemption: Georgia net income limit \$10,000

H5 – Veteran \ Spousal: No income limit

H6 – Senior Exemption: Georgia net income limit \$15,000

H7 – Senior or Disability Exemption: Gross income limit \$16,000


H8 – Senior Exemption: Gross income limit \$16,000


H9 – Senior Exemption: Federal adjusted gross income limit \$88,226

H10 – Disabled Veterans: \$10,000 limit Georgia net for schools and \$81,080 for all other levies

Motor Vehicle Collections





Effective July 2019, the State passed House Bill 329, which changed the distribution of State and local government motor vehicle funds established in the new Title Ad Valorem Tax (TAVT) beginning March 1, 2013. The original bill discontinued ad valorem taxes for new vehicles and replaced it with a Title Ad Valorem Tax. The new tax created a "True-Up" amount to ensure local governments would receive the same revenue they received in 2012. Any remaining funds would be distributed to the various local governments according to a factor that they establish.


Due to declining revenues for local governments, the State revisited the law and established a new formula for TAVT disbursements, which included a much lower percentage for the State and elimination of the Ad Valorem True-up.

State Kiosks for Tag Renewal



In April 2016, The Office of the DeKalb County Tax Commissioner took the initiative and began offering self-service kiosks for taxpayers. These kiosks represent a partnership between the Tax Commissioner, Georgia Department of Revenue, Kroger, and the service provider.






