Happy 200th Birthday, DeKalb! Since 1822 and earlier, tax offices in Georgia have collected the tax revenue necessary to finance governmental operations. Today, tax offices have taken on additional duties as required through state and local legislation. Tax office services have grown in relation to the growth of the county it serves. Just look at a few of the services we offer in DeKalb: tag and title registration, emission testing requirements, insurance verification, property tax-homestead applications and validation, tax billing and delinguent tax collection, tax digest preparation and dissemination, Community Improvement District (CID) certification, and more.

I want to thank the men and women of this office for providing a high level of service to DeKalb County. It is not an overstatement to acknowledge that much of what is accomplished is due to the staff and their training, desire to serve, and focus. As we continue to move beyond the impacts of COVID-19, this office, in 2022, met its legal and financial objectives with the county and local municipalities.

We have continued our efforts to shift the service delivery paradigm of "walk-in and wait" to now include more web services and an appointment system for advance planners. We also provide services and information through our website, **DeKalbTax.org**, along with mail slots and drop box options at all three tax office locations and tag renewal kiosks at five Kroger locations throughout the county.

In addition to our website, DeKalb citizens have access to online, motor vehicle services for renewals, address changes, insurance status checks, tax estimates, vehicle/tag cancellation, and more at **eservices.drives.ga.gov**. Seniors can now receive most motor vehicle and property tax services at the Lou Walker Senior Center one day a week, and more senior centers will be added as we move forward with this pilot service.





The DeKalb County Tax Digest is presented annually to the Georgia Department of Revenue for approval prior to the creation of tax bills. The property tax digest is the sum of all the assessed values, after exemptions, of properties to be taxed within the County.

The Board of Tax Assessors is the agency charged with the responsibility of establishing the fair market value of property for ad valorem taxation purposes. This Board determines property values based on recent sales and market conditions.

Notices of current value assessment are mailed to all property owners each spring. If a property owner has a disagreement with a property appraisal, an appeal may be filed up to 45 days from the notice date on the assessment form.

The governing body of each taxing authority annually establishes the millage rate, which is the determining factor in the calculation of taxes.

It is the responsibility of the Tax Commissioner to calculate tax bills based on the values set by the Assessor's Office and the millage rate established by the Board of Commissioners or City Council.

Real estate and personal property net billings are calculated by taking the total property tax bills and subtracting adjustments to equal the net total billings. The percent of real estate and property tax collections are based on the amount of the net billings that have been collected in a given year.



# HOMESTEAD EXEMPTIONS



### ABOUT HOMESTEAD EXEMPTIONS

Homestead exemptions provide a reduction in annual property taxes and are available to individuals who own and occupy the home in the county, including the City of Atlanta portion in DeKalb. Special exemptions are also available for eligible seniors ages 62 and older, disabled residents, and disabled veterans.

Individuals applying for the first time must own and occupy the home as their primary residence as of January 1, 2023, have all vehicles registered in DeKalb County, file income taxes from the property, and not have a homestead exemption anywhere else. Applications received after April 1 will be processed for the following year.

H7 – SENIOR OR DISABILITY EXEMPTION: GROSS INCOME LIMIT \$16,000



**H9 – SENIOR EXEMPTION:** FEDERAL ADJUSTED GROSS INCOME LIMIT \$96,160

H10 – DISABLED VETERANS: \$10,000 LIMIT GEORGIA NET FOR SCHOOLS AND \$101,754 FOR ALL OTHER LEVIES

# DELINQUENT PROPERTY TAX



### LIENS ISSUED VERSUS PROPERTIES SOLD



Delinquent properties that have not been paid as of December 31st will have a lien placed on the property. Once the lien is placed on the property, fees and penalties will be added to the tax amount due. If payment is not received, the property is subject to being sold at a tax sale.

Tax sales are held on the first Tuesday of each month, usually between April and December. Notices of tax sales are published once a week for four weeks in *The Champion Newspaper* prior to the sale.



The Office of the DeKalb County Tax Commissioner has a division solely responsible for the collection of delinquent taxes (taxes not received by the payment deadline).



# MOTOR VEHICLE COLLECTIONS

2022 ANNUAL REPORT





Ad Valorem tax is based on the value of the vehicle. The tax must be paid at the time of sale by Georgia residents or within six months of establishing residency by those moving to Georgia.







### TAVT COLLECTIONS

Title Ad Valorem Tax (TAVT) became effective on March 1, 2013. TAVT is a one-time tax that is paid at the time the vehicle is titled. It replaced sales tax and annual ad valorem tax (annual motor vehicle tax) and is paid every time vehicle ownership is transferred or a new resident registers the vehicle in Georgia for the first time.

DeKalb County Tax Commissioner Irvin J. Johnson, an elected constitutional officer, is responsible for billing, collecting, and disbursing \$1.6 billion in personal and real property taxes, and administering homestead exemptions for the nearly 260,000 property owners. Also serving as an agent for the State of Georgia, the tax commissioner handles all aspects of motor vehicle registrations, including managing the collection of motor vehicle taxes, issuing vehicle tags and titles, and processing vehicle registration renewals for citizens and businesses located in DeKalb County, Georgia.
