The goal of the DeKalb County Tax Commissioner's Office is to provide excellent customer service to all visitors and constituents: citizens, taxpayers, public officials, businesses, and governmental entities while meeting our State constitutional duties as required by Georgia Law and the rules and regulations of the Georgia Department of Revenue.

As we enter 2019, we pause to reflect on how well we performed relative to our goals, objectives, and challenges of 2018. Although change is inevitable, our commitment to be responsible stewards of taxpayer funds has not changed. Our responsibility to meet all fiduciary and legal requirements of the State of Georgia are not subject to external influences. We remain steadfast in doing what is right. We believe in being accountable and transparent at all times.

This past year, we continued to achieve high marks on customer service. We successfully passed State, County, and City accounting and financial audits. We invested in staff training and development, technology enhancements, and transactional cost control. Through



the continuing efforts of our excellent staff—current and previous—our reputation still ranks up there with the best in Georgia and DeKalb County.

In 2018, we introduced **OUR Vision** about the values we deem important to achieving our stated mission. We are committed to providing excellent customer service; transparency; meeting ethical standards; practicing personal integrity; and valuing a positive work ethic, honesty, and teamwork. We are working towards the realization of **OUR Vision** by questioning old assumptions about how to operate and accepting the challenge of finding better ways to conduct the business of the taxpayers.

Community service and education are becoming hallmarks of our Property Tax Division as exemplified by the steady requests we receive for on-site visits around the County. We are engaging with several senior centers to supplement our on-going service delivery strategy. We are placing a special focus on educating seniors and veterans as well as current and potential homeowners about tax-saving exemptions for homes and motor vehicles. We continue to provide tax bill seminars at senior centers, homeowner associations, and other organizations throughout the County.

Over the past two years, our three self-service motor vehicle registration kiosks have handled more than 48,000 transactions. Your tax dollars are at work, and we are the leader in using this technology. We have provided more convenience through expanded service options without adding labor cost or job loss. These kiosks are conveniently located within the County and allow you to renew your vehicle tag before, during, and after regular office hours. Two more kiosks are currently scheduled for deployment in early 2019.




In 2018, The Tax Commissioner's Office accomplished the following:

- Received and disbursed over \$1 billion to County, School, Cities, TAD, and CIDs authorities
- Partnered with County administration for successful implementation of SPLOST tax initiative by providing benefit analysis and billing data
- Launched the redesign of the Tax Commissioner's website to improve navigation, usability, and to add average "wait time" monitoring for each location
- Initiated training and development for implementation of DRIVES (Driver Registration Integration Vehicle Enterprise System) software
- Increased number of new Homestead applications and new senior exemptions through effective community outreach efforts
- Reduced credit card fees from 2.35% to 2.29%, saving taxpayers money on card transactions
- Enhanced video security and access control at all office locations for the safety of taxpayers and employees and to verify cash transactions
- Secured funding to renovate Memorial Drive office to provide more space for customers waiting to be screened. Renovations completed May 2019
- Installed "wait time" TV monitors in the Central Office motor vehicle lobby to inform customers
- Completed first phase of office-wide Quality Systems Management procedures manual to memorialize internal procedures to create consistency in service deliverables
- Collected over 96% of current year taxes
- Achieved Property Tax Digest approval for another consecutive year, which prevented a delay
 in tax billing thus avoiding delay in county revenue generation
- Operated within county budget (multi-year achievement)
- Returned unused, budgeted funds to general fund balance (multi-year achievement)


The DeKalb County Tax
Digest is presented annually to
the Georgia Department of
Revenue for approval prior to
the creation of tax bills. The
Property Tax Digest is the sum of
all of the assessed values, after
exemptions, of properties to be
taxed within the County.


The Board of Tax Assessors is the agency charged with the responsibility of establishing the fair market value of property for ad valorem taxation purposes. This Board determines property values based on recent sales and market conditions.

The governing body of each taxing authority annually establishes the millage rate, which is the determining factor in the calculation of taxes.

It is the responsibility of the Tax Commissioner to calculate tax bills based on the values set by the Assessor's Office and the millage rate established by the governing body.

Notices of current assessment are mailed to all property owners each spring. If a property owner has a disagreement with a property appraisal, an appeal may be filed up to 45 days from the notice date on the assessment form.






Gross Digest Value

Five-Year Net Billed and Percent Collected


The net billed amount for real estate and personal property is the amount of taxes expected to be collected after adjustments, which are primarily due to appeals to property values. The Tax Commissioner generally collects in excess of 97% of the net billed amount by December 31st of each year. In 2018, the City of Atlanta was delayed in setting their millage rates, which resulted in a 2019 tax payment deadline that impacted the year-end receivables rate.

ATLANTA IMPACT

Each year, the DeKalb County Tax Commissioner's Office makes every effort to ensure that taxpayers are aware of their options for tax exemptions. Notices about exemptions are included on the back of the envelopes that include property tax bills; new property owners are mailed homestead applications; a slideshow explaining the application process is available on our new website along with a link to the application; and throughout the year, staff attend dozens of community events in order to educate the public about tax exemptions and other services and processes handled by the Tax Commissioner's Office.



Types of Homestead Exemptions

H1 - Basic: No income limit

H3 - Senior or Disability: Georgia net income limit \$10,000
H4 - Senior Exemption: Georgia net income limit \$10,000

H5 - Veteran\Spousal: No income limit

H6 – Senior Exemption: Georgia net income limit \$15,000

H7 – Senior or Disability Exemption: Gross income limit \$16,000


H8 – Senior Exemption: Gross income limit \$16,000

H9 - Senior Exemption: Federal adjusted gross income limit of \$88,226

H10 - Disabled Veterans: \$10,000 limit Georgia net for schools and \$81,080 for all other levies






The Office of the DeKalb County Tax Commissioner has a division solely responsible for the collection of delinquent taxes (taxes not received by the payment deadline). Noted in the graph below, prior year Real Estate and Personal Property uncollected taxes are consistently below .25% of the net amount billed. This means that in excess of 99.75% of ad valorem taxes are collected.






Delinquent properties that have not been paid as of December 31st will have a lien placed on the property. Once the lien is placed on the property, fees and penalties will be added to the tax amount due. If payment is not received, the property is subject to being sold at a tax sale. These tax sales are held on the first Tuesday of each month, usually between April and December. Notice of tax sales are advertised in *The Champion Newspaper* once a week for four weeks prior to the sale.







In September of 2018, The DeKalb County Tax Commissioner's Office launched the redesigned website **www.dekalbtax.org**. The purpose of the website is to deliver critical information to DeKalb County taxpayers regarding property and motor vehicle taxes. The goal of the redesign was to provide more information and online services and make the website more user-friendly.

On the home page, a prominent menu with drop-down features lets taxpayers navigate easily to the information they need and the tasks they want to complete during their visit. Colorful icons (shown above) now direct users to specific areas of the website where pertinent information can be found. DeKalb County has a diverse population and these icons can be especially helpful for taxpayers who are non-native, English-language speakers.


Citizens can now complete the following tasks by visiting our website:
